ORDER

The Social Welfare (TW.Ser.III.1) Department have stated that in the ref.1st read above, the Commissioner of Tribal Welfare, AP, Hyderabad, reported that over a period of time the activities in Integrated Tribal Development Agencies in the State have increased many folds. Therefore, for effective implementation of various welfare and developmental programmes of the Government and to meet the expectations of the tribals living in ITDA areas, submitted proposals for sanction of 245 additional posts in the categories of Gazetted, Non-Gazetted and LGS by suppressing 62 surplus posts identified in all ITDAs sanctioned in the GOs are shown in Annexure-I.

After careful examination of the matter, Government hereby accord sanction of (102) posts of Gazetted and Non - Gazetted categories to be filled up on regular basis in the ITDAs with immediate effect as mentioned in Annexure-II to this order. The details of posts abolished are mentioned in Annexure-I to this order.

3. Government also hereby accord permission to outsource of (143) posts as mentioned in Annexure-III to this order.
