ORDER:

The Project Officer, ITDA, Utnoor had sent proposals earlier in the year 2003 stating that for the last 5 years about 40 Multipurpose Health Assistant (Male) posts were lying vacant in Primary Health Centers of tribal area and he had selected 40 Scheduled Tribe candidates with Intermediate qualification from local area (under vocational training programme) and sent to Multipurpose Health Assistant (Male) Training course at Nizamabad and the individuals have completed the training course in the month of December, 2002 and requested to fill up these back log vacancies.

- 2. Accordingly, orders were issued in the G.O. 1st read above, permitting the District Collector, Adilabad / Project Officer, ITDA, Adilabad to fill up by Scheduled Tribe backlog vacancies of Multi Purpose Health Assistant (Male) reserved in the agency and Sub Plan areas of Utnoor, Adilabad District based on merit duly following the orders issued in G.O.Ms.No.68, Social Welfare (V) Department, dated 16.4.1988. Thereon, the Project Officer, ITDA, Utnoor had appointed 38 Scheduled Tribe candidates as Multipurpose Health Assistant (Male) on contract basis in three different spells.
- 3. The Director of Health, A.P., Hyderabad, has sent proposals vide his letter 2nd read above, requesting for regularizing the services of 38 Scheduled Tribe candidates who were appointed as Multipurpose Health Assistants (Male) in tribal areas of Adilabad District on contract basis instead of regular basis in terms of G.O.Rt.No.784, Health, Medical and Family Welfare (J2) Department dt.25.9.2003.
- 4. Government after careful examination, noticed that the candidates appointed were given the requisite training by ITDA and these individuals became eligible as per the instructions of Government and however, the Project Officer, ITDA, Utnoor had appointed the candidates on contractual basis instead of regular basis. Hence, it has been decided to regularize the services of these 38 Scheduled Tribe candidates from the date of their appointment on contract basis.

- 5. Accordingly, the Government hereby permit the Director of Health, A.P., Hyderabad to regularize the services of 38 Multipurpose Health Assistants (Male) who were appointed against the Scheduled Tribe backlog vacancies in terms of G.O.Rt.No.784, Health, Medical and Family Welfare (J2) Department dt.25.9.2003 on contract basis with effect from their initial appointment on contract basis as Multi Purpose Health Assistant (Male).
- 6. The Director of Health, A.P., Hyderabad shall take necessary action accordingly.
- 7. This order issues with the concurrence of Finance (PC.III) Department vide their U.O.No.14768/54/A1/PC.III/09, dated 7.2.2009 and U.O.No.6880-A/25/A1/PC.III/09, dated 2.3.2009.
