In the circumstances explained by the Commissioner of Family Welfare & Ex-Officio Principal Secretary to Government in the reference third read above, the Government, after careful examination of the matter hereby accord administrative sanction for an amount of Rs.4.05 crores (Rupees four crores and five lakhs only) for construction of 38 (thirty eight) Birth Waiting Homes in Tribal Areas of 11 Districts of Andhra Pradesh State annexed to this order at an estimated cost of Rs.10.4 lakhs for each Birth Waiting Homes, under NRHM-RCH-II Project for which the Project Implementation Plan has already been approved by the Government of India as well as by the State Government in the references first and second read above.

2. The following objectives are envisaged in the scheme :
 - a) Increase of institutional deliveries in tribal areas, so that MMR & IMR will be reduced;
 - b) improved availability of health care services for the tribal population in a reliable manner
 - c) More convenient accessing of health care services by the tribal population in shandies where they go for other purposes also;

3. The Birth Waiting Homes sanctioned in this order shall be under the management control of the Hospital Development Society of the CHC/Area Hospital of the area. The Birth Waiting Homes situated in the ITDA areas shall be handed over to the ITDAs of the respective Districts for their maintenance, soon after completion of the construction.

4. The expenditure for construction of the Birth Waiting Homes shall be met from the NRHM-RCH-II Project funds. The maintenance of the Birth Waiting Homes shall be met from the Family Welfare Buildings Maintenance under State Non-Plan funds. The costs for electricity, water supply and security shall be met from regular budget of the Community Health Centre/Area Hospital that the area in which the BWH is situated or from the funds of Hospital Development Society.
