O R D E R:

In the reference 2nd read above, proposals under scheme Article 275(1) for the year 2014-15 for construction of buildings for (11) new Ekalavya Model Residential Schools (EMRS) with an estimated cost of Rs.13200.00 lakhs (@Rs.1200.00 lakhs each building) was submitted to Ministry of Tribal Affairs, Govt. of India.

2. In the reference 3rd cited, the Ministry of Tribal Affairs, Govt. of India has communicated the decisions of the Project Appraisal Committee under schemes SCA to TSP, Article 275(1) and other programmes/schemes for the year 2014-15. In regard to proposal for construction of EMRS, the Project Appraisal Committee has approved that during 2014-15 an amount of Rs.350.00 lakhs each would be provided for construction of (10) EMRS sanctioned during 2012-13 and out of which (3) EMRS would be supported out of allocation under Article 275(1) and (7) EMRS would be supported out of allocation under SCA to TSP.

3. In the reference 5th read above, the Govt. of India has conveyed sanction for an amount of Rs.2937.82 lakhs approved by PAC for the year 2014-15 under SCA to TSP and out of total amount of Rs.2937.82 lakhs approved by the Project Appraisal Committee (PAC), an amount of Rs.2450.00 lakhs has been apportioned @ Rs.350.00 lakhs each for construction of (7) new EMRS during the year 2014-15.

4. In the reference 9th read above, the Govt. of India has conveyed sanction for an amount of Rs.3110.00 lakhs as approved by PAC for the year 2014-15 under Article 275(1) and out of total amount of Rs.3110.00 lakhs approved by the Project Appraisal Committee (PAC), an amount of Rs.1050.00 lakhs has been apportioned for the construction of (3) EMRS @ Rs.350.00 lakhs each.

5. In the reference 8th read above, the Secretary (FAC), APTWREI Society (Gurukulam), AP, Hyderabad has requested the Government to issue necessary Administrative Sanction in favour of the E-in-C, TW, Hyd. for construction of (10) new EMRS i.e. (7) EMRS under SCA to TSP and (3) EMRS under Article 275(1) with an estimated cost of Rs.1200.00 lakhs per each EMRS.

6. Government, after careful examination of the matter, hereby accord Administrative Sanction for construction of (10) Ekalavya Model Residential Schools with an estimated cost of Rs.120.00 crore (Rupees One Hundred and Twenty crore only) @ Rs.12.00 crore per each EMRS, as detailed below:

The expenditure for the works sanctioned in para-(6) above shall be met from out of funds being released by Ministry of Tribal Affairs, Govt. of India under the central schemes of "Article 275(1) of Constitution of India" and "Special Central Assistance to Tribal Sub Plan (SCA to TSP)" for construction of (10) Ekalavya Model Residential Schools.

8. The Director of Tribal Welfare, AP, Hyderabad and the Engineer-in-Chief, Tribal Welfare, AP, Hyderabad are requested to take immediate necessary action and to ensure that the works are completed within 1 ½ years from the receipt of the funds duly following the guidelines issued by the Govt. of India for setting up of Ekalavya Model Residential Schools from time to time.

9. The Director of Tribal Welfare, AP, Hyderabad is requested to utilize the funds released by Gol during 2014-15 i.e. Rs.350.00 lakhs each for construction of (7) new EMRS under SCA to TSP and Rs.350.00 lakhs each for construction of (3) new EMRS under Article 275(1). She shall ensure that the balance amount to be released by Govt. of India for the above sanctioned works shall be included in the further proposals under Article 275(1) of Constitution of India.
