ORDER:-

In the reference 1st read above, Government have sanctioned (20) Youth Training Centers (YTC) at estimated cost of Rs.300.00 lakhs each under Tribal Sub Plan 2013-14. The constructions of these YTCs are approved by the Nodal Agency for TSP in its meeting held on 13-05-2013 and State Council for Development of SCs and STs in its meeting held on 21-05-2013.

2. In the reference 2nd read above, the Hon'ble Minister for Price Monitoring, Consumer Affairs, Food & Civil Supplies, Government of AP has represented for construction of Youth Training Center at Ramagiri Mandal in Rappathadu Constituency instead of Bukkarayasamudram.

3. In the reference 4th read above, the Director of Tribal Welfare has stated that as the required 2.00 acres of land for construction of YTC at Ananthapuram Town is not available, it was proposed to take up the work at Bukkarayasamudram and the same was placed before the Nodal Agency for TSP in its 4th meeting held on 02-12-2013 and the Nodal Agency for TSP has agreed for modifications/ alterations of already sanctioned works pertaining to TW Dept. vide its resolution No.31/12.

4. In the reference 5th read above, Government have agreed to change of location of YTC from Ananthapuramu (Bukkarayasamudramu) to Ramagiri Mandal Headquarter of Rappathadu Constituency and the DTW has been requested to place the matter before the Nodal Agency for TSP as well as State Council for SCs and STs for its approval.

5. In the reference 7th read above, the DTW has stated that the matter was placed before the 12th Nodal Agency for TSP and Nodal Agency vide Resolution No.28 considered the shifting of location of construction of Youth Training Centre from Bukkarayasamudram to Ramagiri Mandal Head Quarters of Rappathadu Constituency and recommended to place before the State Council for Development of SCs and STs for ratification.

6. The Director of Tribal Welfare has requested to issue revised administrative sanction for shifting of location of construction of Youth Training Centre from Anantapuram (Bukkarayasamudram) to Ramagiri Mandal Head Quarters of Rapathadu Constituency.

Government after careful examination of the matter and hereby accord revised administrative sanction for shifting location of Youth Training Centre from Ananthapuram (Bukkarayasamudram) to Ramagiri Mandal Headquarter of Rapthadu Constituency in Ananthapuram District and recommended to State Council for Development of SCs and STs for ratification.

8. The Director of Tribal Welfare/ Engineer-in-Chief (TW), Andhra Pradesh, Hyderabad shall take further necessary action accordingly.
