O R D E R:

The Govt. of India, Ministry of Tribal Affairs, New Delhi has launched a new Central Sector Scheme (CSS) "Vanbandhu Kalyan Yojana(VKY)" during the current financial year 2014-15 with it aims at creating enabling environment for need based and outcome oriented holistic development of the tribal peoples. During the year 2014-15, the scheme is being implemented in one block each of the States having Scheduled-V areas.

2. In the reference 2nd read above, Govt. of India have approved for an amount of Rs.10.00 crore under scheme "Vanbandhu Kalyan Yojana(VKY)" to take up as a pilot project in G.Madugula Mandal (Block) in ITDA, Paderu, Visakhapatnam district during 2014-15.

3. The Govt. of India have conveyed sanction and released an amount of Rs.750.00 lakhs as 1st instalment in the reference 3rd read above and released Rs.250.00 lakhs as 2nd instalment in the reference 5th read above, to carry out the activities under Scheme "Vanbandhu Kalyan Yojana(VKY) for the year 2014-15. The activities to be executed in the G.Madugula Mandal (Block) in ITDA, Paderu Visakhapatnam district are as detailed below.
