**ORDER:**

In pursuance of the orders issued in the GO 1st read above, Departmental Promotion Committees were first constituted in 1985 to consider proposals for promotion to Heads of Department (Non-Cadre), Additional / Joint Secretaries to Government (Non-Cadre) level posts and 4<sup>th</sup> Level Gazetted and above Posts; and Screening Committees for 3rd Level Gazetted Posts in the State and the same were last reconstituted vide GOs 2<sup>nd</sup> to 5<sup>th</sup> read above with a term of office up to 31-12-2015 or till their reconstitution, whichever is later. The term of the Office has completed by 31.12.2015. Hence, necessity has arisen to reconstitute the Committees.
