Tribal Welfare Department – Shifting of Headquarters of District Tribal Welfare Office from Eturunagaram to Warangal in Warangal District – Creation of a new unit office of Assistant Project Officer (Tribal Welfare) in the Headquarters of ITDA, Eturunagaram – Redeployment of existing staff of ITDA and office of Commissioner of Tribal Welfare and allocation of work between new unit office and the Head Quarters Office - Orders – Issued.

ORDER:

In the G.O. 1st read above, orders were issued to relocate the office of the District Tribal Welfare Officer / Assistant Project Officer (TW), ITDA, Eturunagaram at Warangal in view of the fact that large population in Warangal District is spread over outside agency area also. Whereas Project Officer, ITDA, Eturunagaram submitted a proposal to create one unit of the office of District Tribal Welfare Office at Eturunagaram to look after the implementation of Tribal Welfare Programs in the agency area. Commissioner of Tribal Welfare, A.P., Hyderabad in the reference 2nd read above has recommended the proposal of the Project Officer, ITDA, Eturunagaram and requested the Government to redeploy the existing staff and sanction the new unit as it is essential for effective functioning and implementation of Tribal Welfare Programs in the Agency area.

2. Government after carefully examining the proposal of Commissioner of Tribal Welfare have decided to create a new unit of Assistant Project Officer (Tribal Welfare) at the headquarters of ITDA, Eturunagaram. The post of APO (TW) will be filled up by an officer in the cadre of District Tribal Welfare Officer of the Tribal Welfare Department. This APO (TW) will be functioning from the office of the ITDA under the administrative control of Project Officer, Eturunagaram and will be assisted by (2) Senior Assistants and (1) Junior Assistant.

3. This post of Assistant Project Officer (TW), Eturunagaram is created by suppressing one post of Assistant Director in TCR & TI of Tribal Welfare Department. The posts of (2) Senior Assistants and (1) Junior Assistant is ordered to be redeployed from the available posts of Senior Assistant and Junior Assistant in the Office of the Assistant Project Officer (TW) / District Tribal Welfare Officer, Warangal.

4. Consequent to the above, the offices of APO(TW), Eturunagaram and APO (TW), Warangal will have the following staffing pattern:

2. Senior Assistant 2 (Two)

3. Junior Assistant 1 (One)

3. Senior Assistant 1 (One)

4. Junior Assistant 1 (One)

5. The work distribution between APO (TW), Eturunagaram and APO (TW), Warangal is ordered to be as follows:

e) All matters pertaining to the establishment and staff of the Tribal Welfare Department

f) Budget, releases and reconciliation of the TW Schemes as authorized by Project Officer, ITDA from time to time

g) Any other work as entrusted by Project Officer, ITDA, Eturunagaram from time to time

Assistant Project Officer (TW), Warangal

a) Supervision and control over

(i) Assistant Tribal Welfare Officer,
Hanmakonda

(ii) Assistant Tribal Welfare Officer,
Mahabubabad

b) Day to day administration of the TW Educational Institutions functioning under the control of the above two ATWOs

c) All matters relating to the scheme of Postmatric Scholarships to the ST students studying in the institutions located in the jurisdiction of the above two ATWOs

d) All matters relating to the Scheme of Prematric Scholarships and Best Available Schools concerning the jurisdiction of the above two ATWOs

e) any other work as entrusted by Project Officer, ITDA, Eturunagaram from time to time

6. Further it is hereby ordered that the Office of the Assistant Tribal Welfare Officer, Hanmakonda shall be located in the Office of District Tribal Welfare Officer / Assistant Project Officer (TW), Warangal and will be considered as part and parcel of the latter.
