

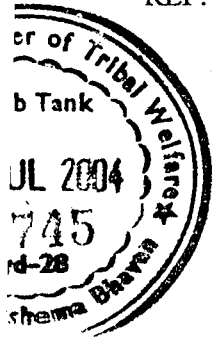

SUB: Tribal Welfare Department – Estt – Office of the Commissioner of Tribal Welfare – Rule of Reservation for promotion to the teacher posts in the scheduled areas in favour of local STs – Certain clarification – Issued.

7 The attention of the Commissioner of Tribal Welfare, Hyderabad is invited to the references cited and he is informed that in G.O. first cited, orders were issued stating that the post of teachers in Educational Institutions in the scheduled area of the State shall be filled in only by the local members of the scheduled tribes.

In G.O. second cited an amendment was issued to the G.O. first cited stating that provided that the post of teachers such as B.Ed.Assistants, Telugu Pandits, Craft Assistants and Hindi Pandits filled in by the members of non-tribals having requisite qualifications on temporary basis till the qualified local tribals are available. Provided further that the persons so appointed shall be replaced by the qualified local tribals as and when such tribals are available.

In G.O. third cited, orders were issued in super-session of the orders issued in G.Os. first and second cited directing that all the posts of teachers in the schools situated in scheduled areas in the State of Andhra Pradesh shall be filled in by the local scheduled tribe candidates only, out of whom 33 1/3% shall be women.

In G.O. fifth cited, orders were issued providing Rule of Reservation in promotions in favour of SCs & STs wherein 6% reservation in respect of STs is provided for.

In Govt.Memo. sixth cited, the Director of Tribal Welfare, Hyderabad/all Project Officers of ITDAs were requested to follow the existing rules including rule of reservation issued in G.O. fifth cited for effecting promotions based on merit-cum-seniority of all eligible teachers including non-tribals who were appointed prior to issue of the G.O. third cited to various categories and to that extent the condition prescribed in the G.O. second cited stand modified.

In the reference seventh cited, the judgment of High Court is the very basis of the G.Os. first and second cited which are not enforce as the orders were issued in G.O. third cited in super- sessions of G.Os. first and second cited and orders issued vide reference sixth cited modify the orders of reference 2nd cited.

The clarification issued in Govt. Memo. sixth cited are hereby reiterated and the Commissioner of Tribal Welfare, Hyderabad/all Project Officers of ITADs in the State are requested to take action accordingly.
