ORDER:

In the reference 7th read above, orders were issued for providing promotional channel to the post of Hostel Welfare Officer Grade-II from the category of Class-IV employees on the following conditions:

- i) Those Graduates Class-IV employees with B.Ed. qualification are eligible for promotion to the post of Hostel Welfare Officer Grade-II in Tribal Welfare Department
- ii) Those Class –IV employees who have completed 3 years of service shall be considered for promotion to the category of Hostel Welfare Officer Grade -II in Tribal Welfare Department.
- iii) The posts of Hostel Welfare Officer Grade -II in Tribal Welfare Department shall be filled in by direct recruitment and by promotion of Class-IV employees in the ratio of 10:1 respectively.

2. In the reference 8th read above, the Andhra Pradesh Government Social Welfare Department Hostels Class-IV Employees Central Association, Hyderabad, have represented to exempt from acquiring B.Ed. qualification for providing promotional channel to the post of Hostel Welfare Officer Grade-II from the category of qualified Class-IV employees who have acquired Degree qualification and working in Tribal Welfare Department and to issue an amendment to G.O.Ms.No.88, Social Welfare (TW.Ser.III A1) Department dated 15.5.2008.

3. The Director of Tribal Welfare, Hyderabad .in the ref. 9th read above, has stated that the Class-IV employees Central Association and others represented to issue amendment to the G.O.Ms.NO.88, Social Welfare (TW.Ser.III.A1) Department dated 15.5.2008 for exemption of TTC./ B.Ed. qualification to the Class-IV employees on par with the Social Welfare Department/B.C.Welfare Department, so as to benefit Class-IV employees working in the Tribal Welfare Department since the above G.O, is issued on certain conditions.

4., The Government after careful examination in the matter in detail, hereby decided to exempt the Class-IV employees working in Tribal Welfare Department from acquiring B.Ed. qualification for promotion to the post of Hostel Welfare Officer Grade-II. Accordingly, the following amendment is issued.

AMENDMENT

In G.O.Ms.No.88, S.W. (T.W.Ser.III.A1) Department dated 15.5.2008, in Sub-Para (i) of Para 5, the words “with B.Ed. Qualification” shall be deleted.

5. The Director of Tribal Welfare, Hyderabad is requested to take necessary action in the matter.
