ORDER:

The Right to Information Act, 2005 provides for setting out the practical regime of right to information for citizens to secure access to information under the control of Public Authorities, in order to promote transparency and accountability in the working of every public authority, the Constitution of a Central Information Commission and State Information Commissions and for matters concerned therewith or incidental thereto.

2. The Right to Information, Act, 2005, Casts an obligation, under Section 5, on each public Authority, to designate the following, in all administrative units and offices under it, by 22.9.2005 (i.e. with in 100 days from the date of enactment of the Act).

- a) State Assistant Public Information Officer under Section 5(2) of the Act to receive applications for information or appeals under the Act to forward the same forthwith either to State Public Information Officer or to the Officer who is senior to the State Public Information Officer.
- b) State Public Information Officer under Section 5(1) of the Act to provide information with in the time limit specified in the Act.
- c) Officer who is senior to the rank of State Public Information Officer to receive the applications for information, or appeals sent by the State Assistant Public Information Officer, as contemplated under Sub-Section (1) of Section 19 of the Act to dispose with in the time frame stipulated in the Act in each Public Authority.

3. In compliance with the statutory requirements indicated above, the Heads of Departments, under the control of TW Dept. Vice Chairman and Managing Director, Girijana Cooperative Corporation Ltd., Visakhapatnam have furnished their proposals in the reference 2<sup>nd</sup> and 3<sup>rd</sup> read above for nominating Asst. Public Information Officers, Public Information Officers, and Officers senior to Public Information Officers.

4. Government, after careful consideration, hereby nominate the Officers in TW Dept. in the Secretariat as well as Heads of Departments under the control of TW Dept. District Officers and Sectional Officers i.e. TCR&TI, Gurukulam Chief Engineer (TW) AP Hyd., TRIPCO and Girijana Cooperative Corporation Ltd., Visakhapatnam under the control of TW Dept. as shown in Annexure I & II

5. All the Heads of Departments under the control of TW Dept. are requested to take necessary action in the matter.
