The Non- Official Members of the Andhra Pradesh Tribes Advisory Council shall be eligible to draw TA / DA as per Annexure-VI (Rule-91) para -5 (Miscellaneous) of Andhra Pradesh Traveling Allowance Rules of 1996. The Commissioner of Tribal Welfare shall be the controlling authority for purpose of countersigning the TA bills of the non-official members of the Council.

The term of the Council hereby reconstituted shall be for a period of three years from the date of issue of orders or till the date on which the Andhra Pradesh Legislative Assembly is first summoned to meet after the next General Elections, whichever is earlier.
