ORDER:

In the G.O. 1st read above, order were issued constituting a High-Level Co-ordination Committee with the Chief Secretary to Government as Chairman, the Secretary to Government, Planning Department, the Secretary to Government. Social Welfare Department, as convener to monitor the implementation of Special -Component Plan.

2. In the G.O. 2nd read above, orders were issued earmarking 16.2% and 6.6% of Plan allocations of all Departments exclusively towards Special Component Plan and Tribal Sub Plan for the development of Scheduled Castes and Scheduled Tribes in the State from 2006-2007. and it was also instructed to take action for earmarking the funds at the time of formulating the Budget Estimates.

3. There is also a Standing Tripartite Committee constituted by the Tribal Welfare Department in the reference 3rd read above : under the Chairmanship of Minister for Tribal Welfare to review exclusively the Tribal Sub-Plan.

4. In the G.O. 4th read above, an Apex Committee has been constituted to over-see the operation of Scheduled Castes Sub Plan and Tribal Sub Plan under the Chairmanship the Chief Minister.

5. However. Government have now decided. to enable more frequent operational reviews to set up a Nodal Agency separately for the Scheduled Castes Sub-Plan and for the Tribal Sub-Plan as indicated below;

6) The Nodal Agencies will review and monitor the allocation, expenditure and implementation of the SCSP/TSP once every two months and ensure that all Departments of Government spend the monies earmarked under Heads of Account '789' & '796' for Scheduled Castes Sub-Plan and Tribal Sub-Plan respectively.

7) Such of those Departments which are not in a position to incur expenditure in proportion to the allocation, the Nodal Agency shall have the power to reappropriate the amounts to other needy Departments which have schemes benefitting Scheduled Castes and Scheduled Tribes.
