#### ORDER:

In the reference 1<sup>st</sup> read above the Planning Commission, Govt, of India have requested the Govt; of Andhra Pradesh to constitute standing Tripartite Committee under the Chairmanship of Minister l/c of the Welfare & Development of Scheduled Tribes to look into all the policy related matters/issues for affective implementation of Tribal Sub Plan.

2. After careful consideration, the Government here by constitute a standing tripartite committee to review the implementation of the strategies of the Tribal Sub Plan (TSP) for STs and to resolve various policy related issues for affective implementation of TSP for STs in Andhra Pradesh State.
3. The composition of the state level standing tripartite committee is constituted with the following:

1	Minister (Tribal Welfare)	-	Chairperson
2	Principal Secretary/ Secretary to Government (Social Welfare)	-	Member
3	Principal Secretary to Govt. (Finance)	-	Member
4	Secretary to Govt. (Planning)	-	Member
5	Secretary to Govt. (Tribal Welfare)	-	Member
6	Representative of Govt, of India	-	Member
7	Commissioner / Director of Tribal Welfare, Hyderabad	-	Convener
4. The terms of reference of the committee will be as under :
  - i) To look into the reasons for not implementing the guidelines concerning TSP and to suggest specific measures for their compliance.
  - ii) To identify specific schemes which would benefit STs under various developmental sectors, their prioritization along with earmarking of funds for them.

Special Component Plan and TSP respectively, for the development of Scheduled Castes and Scheduled Tribes in the State. All Departments of Secretariat and Heads of Departments are, therefore, requested to take action accordingly while formulating the Budget Estimates, for 2006-2007 and send their proposals leaving no scope for further persuasion in this regard.
