### <u>O R D E R:</u>

During 2014-15 an amount of Rs. 5.00 Crores has been allocated to the Department of Youth Services under TSP. During the 9<sup>th</sup> and 10<sup>th</sup> Nodal Agency Meeting and the Secretary, Youth Services, Culture and Tourism has informed that the Department would like to surrender the allocation of Rs. 5.00 Crores under TSP to the Nodal Agency, as the scheme guidelines have not yet been finalized and hence it would be difficult for utilizing the amount during current financial years.

- 2. In the reference 1<sup>st</sup> read above, the Nodal Agency for TSP has agreed to allocate Rs. 5.00 Crores budget under TSP to Information & Public Relations Department by way of Re-appropriation during 2014-15. This budget shall be utilized for creating awareness among STs on TSP and to give wide publicity to the efforts put in by Government under TSP.
- 3. The State Council for Development of Scheduled Castes and Scheduled Tribes held on 27.12.2014 has also approved the same, in the reference  $2^{nd}$  read above.
- 4. In view of the above the Commissioner, Information and Public Relations Department has requested to allocate budget in the reference 3<sup>rd</sup> read above.
- 5. Accordingly, Government after carefully examination, ordered to resume an amount of Rs. 5.00 Corers allocated to Youth Services Dept., in the Plan Budget for 2014-15 and to reallocate the amount of Rs. 5.00 Cores to the Information and Public Relations Department under Tribal Sub Plan during the year 2014-15 by way of re-appropriation to utilize for creating awareness among STs on TSP and to give wide publicity to the efforts put in by Government under TSP.
- 6. The Commissioner, Youth Services, AP, Hyderabad and the Commissioner, Information and Public Relations Department shall take necessary further action in the mater accordingly.
- 7. The above decision was taken with the concurrence of Secretary Finance Department who is a member of the Nodal Agency for TSP in its meeting held on 1.12.2014 and the State Council for Development of SCs and STs whose meeting was held on 27.12.2014 wherein Principal Secretary to Finance was also present.
