**ORDER**

In the G.O. 1<sup>st</sup> read above, orders have been issued constituting a High-Level Coordination Committee with the Chief Secretary to Government as Chairman, the Secretary to Government, Planning Department, the Secretary' to Government, Finance Department, as members, and the Secretary to Government, Social Welfare Department, as convenor to monitor the implementation of Special Component Plan.

2. In the G.O. 2<sup>nd</sup> read above, orders were issued earmarking 16.2% and 6.6% of Plan allocations of all Departments exclusively towards Special Component Plan and Tribal Sub Plan for the development of the Scheduled Castes and Scheduled Tribes in the State from 2006-2007, and it was also instructed to take action for earmarking the funds at the time of formulating the Budget Estimates.

3. There is also a Standing Tripartite Committee Constituted by the Tribal Welfare Department in the reference 3<sup>rd</sup> read above under the Chairmanship of Hon'ble Minister for Tribal Welfare, to review exclusively the Tribal Sub-Plan.

4. However, to review and monitor the Scheduled Caste Sub-Plan and the Tribal Sub-Plan at a higher level on regular basis and to provide necessary guidance to all implementing agencies, Government have decided to set up an Apex Committee under the Chairmanship of Hon'ble Chief Minister and with Members as indicated below in the Committee:
