ORDER:

In the letter read above, the Engineer-in-Chief (R&B), State Roads, Hyderabad has stated that Waddadi – Paderu road (Tatiparthi to Vantalamamidi) in Visakhapatnam district is an important road which connects number of Tribal Mandals. The traffic intensity on this road is 4530 PCU/ day and 2763 CVPD. Therefore, improving the said road is essential to improve the socio-economic conditions.

2. The Engineer-in-Chief (R&B), State Roads, Hyderabad, has hence requested to accord administrative sanction for the work “Improvements to Waddadi – Paderu road from km 14/0 to 23/0 (Tatiparthi to Vantalamamidi) Visakhapatnam district” for Rs.1.22 Crores, under MDR Tribal Areas Sub Plan funds.

3. Government after careful examination of the matter hereby accord administrative sanction for an amount Rs.1.22 Crores (Rupees one crore and Twenty Two Lakhs only) for the work “Improvements to Waddadi – Paderu road from km 14/0 to 23/0 (Tatiparthi to Vantalamamidi) Visakhapatnam district” under MDR-TSP grants for the year 2012-13.

4. The amount sanctioned in para (3) above shall be debited to the head of account “5054 COL on Roads and Bridges; 04-District & Other Roads; 796 Tribal Areas Sub Plan; GH-11 Normal State Plan; SH(07) Major District Roads; 530 Major Works – 531 Other Expenditure”.

5. The Engineer-in-Chief (R&B), State Roads, Hyderabad, shall take further action accordingly.
