The following amendment is issued to clause (V) of of G.O. fourth read above.

**AMENDMENT**

**FOR**

- (V) If Regular and Self Finance Courses for the same subject are run in a particular college, then sanction of scholarships may be restricted to the fee rate sanctioned for the Regular Courses.

**READ**

- (V) If Regular and Self Finance Courses for the same subject are run in a particular College, autonomous or University affiliated, then sanction of scholarship for Self Finance Courses should be restricted to Rs.20,000/- (Rupees Twenty Thousands only) per annum or the actual fee, whichever is less.
