01.	Government Degree College at Buttaigudem, West Godavari District.
02.	Government Degree College at Yeleswaram (V&M), Prathipadu Assembly Constituency, East Godavari District.
03.	Government Degree College at Garla head – quarters in Khammam District.
04.	Government Degree College at Shadnagar, Mahabubnagar District.
05.	Government Degree College at Nakrekal, Nalgonda District.
06.	Government Women's Degree College at Nirmal Town, Adilabad District.
07.	Government Degree College at Morthad Mandal Head quarters in Balkonda Assembly Constituency.
08.	Government Degree College at Maripeda Mandal Head quarters, Dornakal, Assembly Constituency, Warangal District.

2. The Commissioner of Collegiate Education, A.P., Hyderabad, is requested to identify the existing buildings of Junior Colleges or others where the Classes are proposed to be held pending construction of permanent accommodation and send necessary staff and budgetary proposals duly indicating the recurring and non-recurring expenditure towards establishment of eight new Government Degree College sanctioned in Para-1 above, for inclusion in the B.E.Provison 2009-10 and sanction of Teaching and Non – Teaching staff.

3. The Commissioner of Collegiate Education, A.P., Hyderabad, is requested to take necessary further action in the matter accordingly.
