ORDER:-

In the reference 1st read above, orders were issued for opening of (27) Special Hostels during the year 1994-95. In the reference 2nd read above, the Commissioner of Tribal Welfare, Hyderabad issued orders for opening of (33 Post Matric College Hostels for boys and girls in the State and the same had been ratified by the Government in the reference 3rd read above. In the reference 4th read above, certain guidelines were issued for admission into TW Post Matric College Hostels.

- 2. In the references 5th and 6th read above, the Director of Tribal Welfare, Hyderabad has reported that most of the ST students who join Post Matric Courses come from the Tribal Welfare Hostels and Ashram Schools where they have all round support from Government, upto S.S.C.(Secondary School Certificate) and since Post Matric Hostels are not sufficient, the students are dropping-out from studies, and that even in cases where students are continuing their studies, inadequacy of logistic supports have always been affecting their academic performance. The Director of Tribal Welfare, Hyderabad has therefore submitted proposals for opening of additional 50 Post Matric Hostels for S.T. Boys and Girls and furnished the financial implication for openings of additional 50 Post Matric Hostels which are as under:
 - a) Rent for Private buildings to accommodate Students, @ Rs.5,000/- per building (50x5,000x12 = Rs.30.00 Lakhs)

Rs. 30.00 Lakhs

b) Water and Electricity (Utility Payments) @ Rs.2,000/- per hostel (50x2,000x12 = Rs.12.00 Lakhs)

Rs. 12.00 Lakhs

c) Post Matric Scholarships: The students will be sanctioned Post Martci Scholarships on attached hostels rates and this will be met from Post Matric Scholarships Budget. This Post Matric Scholarships will be utilized for the management of the hostels.



- d) Staff Cost: No regular sanctioned staff is required. The college Lecturers nominated by the Principals will function as honorary Directors of the College Hostels. The Watchman will be engaged on contract basis by outsourcing, preferably from labour contract societies or DWCRA Groups. The students admitted in college hostels are sanctioned Post Matrict Scholarships. They will from a mess management committee to maintain the mess. This committee will engage catering service or DWCRA Group and maintains the accounts.
- 3) Government after careful examination of the above proposal of the Director of Tribal Welfare, Hyderabad, hereby accord administrative sanction for opening of (50) Post Matric College Hostels, 25 for boys and 25 for girls, w.e.f. the financial year 2008-09 as indicated in the annexure to this order.
- 4) The expenditure towards Electricity, water and Rents shall be Debited to the following Head of Account:-

Rents for buildings

"2225 Welfare of SCs, STs and OBCs – 02 Welfare of STs – 277 Education – SH(05) Educational Institutions 140 RRT (Non Plan)"

Water and electricity charges

"2225 Welfare of SCs, STs and OBCs – 02 Welfare of STs – 277 Education – SH(05) Educational Institutions 133 Water and Electricity (Non Plan)" and shall be met from the budget provision available in the B.E. 2008-09.
