I the G.O. first read above among others orders were issued under para (5) of G.O first read above that if a scholars fails to pass the annual examination for the course of study for which scholars is awarded a scholarship in that particular year, the scholarship will automatically cease and it will not be renewed. The scholar may however apply for a fresh scholarship again after passing the annual examination in the subsequent year.

2. In G.O second read above, orders were issued duly relaxing the para (5) of the G.O. Ms.No. 421, Education (SW) Department, dated: 25-2-1966 and revised orders were issued in G.O second read above permitting to allow one failure as a special case for sanction of scholarship to SC students studying in Hyderabad Public Schools at Begumpet & Ramanthapur.

3. The Commissioner of Tribal Welfare, A.P., Hyderabad, in his letter 3rd read above, has requested the Govt. to issue necessary orders for extending the benefits to the S.T students also as per G.O Second read above and on par with SC students

4. In the circumstances reported by the Commissioner of Tribal Welfare, A.P., Hyderabad, in his letter third read above, and after careful consideration Govt. hereby permit to allow one failure as special case for sanction of scholarship to S.T students studying in the Hyderabad Public Schools, at Begumpet and Ramanthapur on par with order issued in G.O second read above for SC students.

The Commissioner of Tribal Welfare, A.P., Hyderabad is requested to take necessary action accordingly.
