ORDER:

- In the G.O. first read above, orders have been issued to sanction Food & Maintenance allowance of Rs.250/- P.M. to Kum. K. Panitha, D/o. K. Subramanyam student of VI th class and K.Nagapoornima, D/o. K.Venugopal, IV th class, Hyderabad Public School, Begumpet, Hyderabad from 1997-98 onwards as a special case.
2. In the reference second read above, the Commissioner of Social Welfare, A.P. Hyderabad has informed that there are altogether (30) Scheduled Caste girl students studying in Hyderabad Public School, Begumpet and Ramanthapur and there is no hostel facility for girls in the attached hostel of the both Public Schools and in the special hostel exclusively maintained by Social Welfare Department for the Scheduled Caste students admitted in the Public Schools. The parents of the SC girl students are representing to consider sanction of food and maintenance allowance & they are residing far off places of their relatives and pursuing their studies.
 3. The Commissioner of Social Welfare has further informed that the fees is being reimbursed by the Department but the maintenance charges are not being provided to the SC girls of Hyderabad Public School. As for the SC boys they are being provided accommodation in the school attached hostel and special hostel of Social Welfare Department and at present they are being sanctioned @ Rs.500/- p.m. as mess charges for the SC boys staying in the special hostels. In order to provide uniformity and to avoid drop outs of SC girls studying in Hyderabad Public School, Begumpet and Ramanthapur, the Commissioner of Social Welfare has requested the Government to permit them to provide food and maintenance charges @Rs.500/- p.m. to each Sc girl student on par with the SC boys staying in the special hostel and the required budget will be met from the existing non-plan budget available under SH(04) - Pre-matric Scholarships.
 4. Government after careful consideration of the proposal of the Commissioner of Social Welfare, A.P., Hyderabad hereby accord sanction of food and maintenance allowance of Rs.500/- p.m. to each of the (30) SC girls students of Hyderabad Public School at Begumpet and Ramanthapur from the financial year 2001-2002 onwards as a special case subject to condition that the above girls are sanctioned only one scholarship (i.e., Rs.500/- p.m.) and the day scholarship if already is being paid to the above girls has to be discontinued.

5. The expenditure sanctioned in para-(4) above shall be debited to the following Head of Account :-

6. The Commissioner of Social Welfare, A.P., Hyderabad is requested to take necessary further action in the matter accordingly.
