The attention of Commissioner of Tribal Welfare, A.P., Hyderabad, is invited to the references cited. The eligible S.T students studying in Hyderabad Public School are being reimbursed fees etc right upto 12<sup>th</sup> class. Some students are keen to pursue Intermediate for better opportunities etc. These students got admissions through a highly competitive selection at Hyderabad Public School and passed 10<sup>th</sup> class examination, and deserv encouragement to ensure they complete 12<sup>th</sup> class or equivalent which they would if they continue at Hyd. Public School.

The Commissioner of Tribal Welfare is therefore, permitted to sanction postmatric scholarship to those eligible S.T students who have passed 10<sup>th</sup> class examination from Hyd. Public School and they could not continue their studies in Hyd. Public School for further studies and join other Institutions. The amount of Post Matric Scholarship may be sanctioned, restricting the amount to the reimbursement they would be entitled for at Hyderabad Public School or less, as case may be. The fees, cost of books prescribed, alone shall be reimbursable provided it does not exceed the reimbursable amount at 11<sup>th</sup> & 12<sup>th</sup> of Hyderabad Public School. Such reimbursement shall be subject to verification of student's eligibiity and as per other criteria as income etc.
