ORDER :

The following Addendum is issued to para 4 (g) of the G.O. 3rd read above.

ADDENDUM

- (i) In respect of sanction of Post-matric scholarship to S.C Students studying in Self Finance Courses, at Under Graduate and Post-graduate Levels, the Total Fees reimbursed, shall be only to the extent of Rs. 20,000/- per annum, or the actual fee fixed by University/ Government, whichever is less.
- (ii) The fee structure shall be communicated by the Education Departments concerned/ University, to the Commissioner of Social Welfare, who in turn will forward the same to the Deputy Directors, Social Welfare Department for sanction of Post-matric Scholarships to eligible Scheduled Caste Students. In respect of Self Finance Courses, though the Tuition fee rate prescribed by the Education Departments concerned/ University, may be higher, the Social Welfare Department will sanction the total fee to the extent of Rs. 20,000/- per annum only or the actual Fee whichever is less at Under Graduate & Post Graduate Levels.
- (iii) The Income Certificate should be issued by the Mandal Revenue Officer in respect students claiming reimbursement of fee under all Self Finance Courses. The ceiling on family income shall be the same as per regular courses.
- (iv) In respect of Self Finance Courses, the Deputy Director (Social Welfare) should personally inspect the Institutions, and physically verify the students before sanction of Post-matric scholarships. The Deputy Director (Social Welfare) shall ensure that only genuine and eligible Scheduled Castes Students are sanctioned Post-matric Scholarships, studying in Self Finance Courses.
- (v) If Regular and Self Finance Courses for the same subject are run in a particular college, then sanction of scholarship may be granted.

(vi) Maintenance charges will be sanctioned, as per rates prescribed by the Government, in different Groups of courses.

(vii) The Deputy Directors (Social Welfare) shall compile the figures with respect to sanction of Scholarships to S.C Students in Self Finance Courses separately, and send the report to the Commissioner of Social Welfare, along with Monthly Progress Report of sanctions made under Post-matric Scholarships, before 5th of every month.
