ORDER:

In the G.O 1st read above, the Government has issued orders specifying rent fixation for the private buildings taken on lease by the Government Departments, with an escalation factor of 5% for block of every two years, specifying 6 tier classification of places, which is as follows:-

| d. All Grade-I Municipalities | - Up to Rs.2.25 per sft. |
| e. All other Municipalities | - Up to Rs.1.50 per sft. |
| f. All other rural areas | - Up to Rs.1.25 per sft. |

2. In the reference 3rd read above, orders were issued enhancing the rate of rent fixed in the G.O. 1st read above to the Private Buildings occupied by the Government Department i.e. Tribal Welfare for providing accommodation to the Hostel boarders up to Rs.10/- per sft. in Hyderabad, city only.

3. In the reference 4th read above, the Commissioner of Tribal Welfare has requested the Government to enhance the rates of rents to Private buildings which are occupied to house/locate the Tribal Welfare Post Matric College Hostels at various places in the State. Further, the Social Welfare / Tribal Welfare Department Hostels are located in the same type of areas and situations. Unless rates of rents are one and the same for both the Departments, it would be highly difficult to secure suitable buildings to run the Tribal Welfare Department Post Matric College Hostels as the existing rates of rents were fixed way back in the year 1997.

4. Government after careful examination of the matter, hereby enhance the rates of rents on par with the orders issued in Social Welfare (Edn.) Department in the reference 2nd read above. Accordingly in partial modification of orders issued in the G.O. 3rd read above, hereby enhance the rate of rent fixed in the G.O. 1st read above, in taking Private Buildings on lease by Tribal Welfare Department

towards maintaining (143) Post Matric College Hostels for Scheduled Tribes at various locations in the State, fixing the maximum ceiling of rent for buildings in the six categories of places, as follows: -

| c. All other Corporations and Special grade and Selection grade Municipalities. | -Up to Rs. 5.50 p |
| d. All Grade-I Municipalities | -Up to Rs. 4.50 p |
| e. All other Municipalities | -Up to Rs. 3.00 p |
| f. All other rural areas | -Up to Rs. 2.50 p |

5. The Government further directs that the system of selection and rent for the private buildings shall be based on the procedure prescribed in the read above.

6. The Commissioner of Tribal Welfare, Hyderabad, shall take necessary action accordingly.
