**ORDER:**

In partial modification of the orders issued in the G.O read above with regard to Sanction, Drawal and Disbursement of Post Matric Scholarships, the Deputy Directors of Social Welfare/District Tribal Welfare Officers of the respective districts are hereby declared as Sanctioning, Drawing and Disbursing Officers for the Post Matric Scholarships to S.C./S.T. students respectively in respect of all the recognized Government/University/Aided/Unaided institutions with immediate effect.

2. All the bills relating to the Post Matric Scholarships shall be drawn from the District Treasury/Dy. P.A.O. only.

3. The Deputy Directors of Social Welfare/District Tribal Welfare Officers shall redistribute the budget allotted to the District, Institutionwise and communicate to the DTOs/Dy. P.A.O. Accordingly, DTOs/Dy. PAO shall also maintain the Budget Control Register Institution wise.

4. The Deputy Director of Social Welfare/District Tribal Welfare Officers shall issue sanction orders in respect of an Institution for the second and the subsequent drawals duly mentioning in the sanction orders, the total amount drawn previously, amount disbursed and the details of challan remitted for the un-disbursed amount if any for the previous drawals.

5. The provision of budget shall be watched strictly.

6. Reconciliation of expenditure particulars shall be done every month as per the Government instructions issued from time to time.

7. The disbursement of Post Matric Scholarships shall be made through Account Payee Cheques/Drafts only.

8. The Deputy Director of Social Welfare shall be the Drawing and Disbursing Officer of the o/o Deputy Director, Social Welfare in lieu of Assistant Accountant Officer.
