In the G.O.'s 1st and 2nd cited above, Government have issued comprehensive guidelines for implementation of Economic Support Schemes in respect of Scheduled Tribes Cooperative Finance Corporation Ltd. Hyderabad.

2. Government have decided to enhance the age limit of beneficiaries to 21 to 50 years from the existing age limit of 21 to 45 years in respect of Backward Classes Cooperative Finance Corporation Ltd. The Director of Tribal Welfare, AP, Hyderabad vide reference 4th read above requested the Government to extend the same age limit in respect of ST beneficiaries for the schemes implementing by the AP. Scheduled Tribes Cooperative Finance Corporation Ltd (TRICOR) AP, Hyderabad.

3. After careful examination and in partial modification of the orders issued in the reference 3rd read above , hereby enhance the age limit of beneficiaries of 18 to 50 years for all Self Employment schemes and Skill development programmes in respect of Scheduled Tribes beneficiaries on par with Backward Classes beneficiaries.

4. These orders shall come into effect from the date of issue of G.O.

5. The Managing Director, AP, Scheduled Tribes Cooperative Finance Corporation Ltd, Hyderabad shall take necessary action accordingly.
