**ORDER:**

During the 12<sup>th</sup> State Level Bankers Committee meeting, held at Vijayawada, by the Hon'ble Chief Minister on 12.09.2016, a decision was taken for the constitution of a SLBC Sub Committee on Integration of Bank Finance with Welfare Departments & after due deliberations the Sub Committee has decided to implement the Common Action Plan for all the Finance Corporations of the SC/ST/BC/Minorities Welfare Department from the year 2016-17 onwards and which is accordingly being implemented.

2. In the GO first read above, comprehensive guidelines were issued for implementation of Self Employment Schemes being implemented by APSCCFC Ltd., wherein the Selection of beneficiaries shall be done by a Screening-cum-Selection Committee at the Mandal, Municipality and the Municipal Corporation levels, which was subsequently amended by the G.O. in the reference 3<sup>rd</sup> cited.

3. In view of the feedback received in the meetings of the SLBC Sub-Committee by the Social Welfare Department (the Nodal Department for the implementation of the Action Plans of the Finance Corporations of the Welfare Departments) & from the other stakeholders & duly taking into consideration the Action Plans of the SC/ST/BC/Minorities Welfare Departments, and the deliberations held in the reference 4<sup>th</sup> cited, there is a need to reconstitute the Screening-cum Selection Committees at the Mandal, Municipality and the Municipal Corporation levels in order to make it more representative and functional.

4. Hence, in modification of the order issued in the reference 3<sup>rd</sup> cited the Screening-cum-Selection Committees at the Mandal, Municipality and the Municipal Corporation levels are reconstituted, as detailed hereunder:


