ORDER:

In the G.O. first read above, Government have issued comprehensive guidelines for implementation of Economic Support Schemes by all Welfare Departments.

2. In the reference 2nd read above, the VC & Managing Director, APSCCFC Ltd., Hyderabad has stated that as per the SCAP 2014-15 and 2015-16 for sanction of Economic Support Schemes, the income ceiling limit is Rs.60,000/- in Rural areas and Rs. 75,000/- in Urban areas. He has further informed that during the 1st meeting of Committee Of Persons held on 23-05-2015, it was resolved to recommend to the Govt., for approving the enhanced income ceiling limit of SC families for implementation of Economic Support Schemes under SCAP 2015-16 as follows:

Rs.81,000/- per annum in rural areas. Rs.1,03,000/- per annum in urban areas.

- 3. The VC & Managing Director, APSCCFC Ltd., Hyderabad has requested the Government to enhance the income ceiling as above for sanction under Economic Support Schemes next year SCAP-2016-17.
- 4. Government after careful examination of the matter in detail, hereby enhance the income ceiling limit to all Welfare Corporations for implementation of Economic Support Schemes for the year 2016-17 as follows:
 - 1. From Rs. 60,000/- to Rs.81, 000/- per annum in rural areas.
 - 2. From Rs. 75,000/- to Rs.1, 03,000/- per annum in urban areas.
- 5. Ration card shall be the basic eligibility criteria for the ceiling limit prescribed above.
- 6. All Welfare Corporations of Andhra Pradesh and the VC & Managing Director, APSCCFC Ltd., Hyderabad shall take necessary action accordingly.
