The following notification will be published in the Andhra Pradesh Gazette:-

**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in suppression of the Rules issued in G.O.Ms.No.1224, General Administration (Rules) Department, dated 13<sup>th</sup> August, 1959, the Governor of Andhra Pradesh hereby makes the following Rules for the Andhra Pradesh Translation Services.

**RULES**

**1. Short Title and commencement :**

- (1) These rules may be called the Andhra Pradesh Translation Services Rules, 1995.

**2. Constitution:**

The service shall consist of the following categories of posts in the Andhra Pradesh Translation Service, namely

Category (1): Director

Category (2): (a) Deputy Director (Telugu)  
(b) Deputy Director (Urdu)

**3. Method of Appointment :**

Subject to the other provisions in these rules, the method of appointment for the following categories shall be made as follows:-

<b>Sl. No. (1)</b>	<b>Category (2)</b>	<b>Method of Appointment (3)</b>
1.	Director	i. By promotion from category – 2; or ii. By recruitment by transfer from any services holding the identical / similar posts or iii. If no suitable and qualified persons available in (i) and (ii) methods by direct recruitment.
2.	Deputy Director (Telugu)	By appointment by transfer of Senior Translator (Telugu)
3.	Deputy Director (Urdu)	By appointment by transfer of Senior Translator (Urdu)

**4. Minimum Service :-**

No person shall be eligible for appointment by transfer or by promotion unless he is an approved probationer and has put in not less than three years of service in the category from which promotion or appointment by transfer is made.

**5. Qualifications :-**

No person shall be eligible for appointment to the categories specified in column (1) of the Annexure to these rules by the method specified in column (2) Unless he possesses the qualifications specified in the corresponding entry in column (3) thereof.

**6. Probation :-**

Every person appointed to any of the posts either by promotion or by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

1. Director	(i) By Promotion	Must possess a Degree with Telugu as one of the subject from any University in India established or incorporated by or under a Central Act, Provisional Act or a State Act or an Institution recognized by the University Grants commission as an equivalent qualification.
	(ii) By Direct recruitment	(1) Must possess a B.A. Degree in Telugu or its equivalent qualification from any University in India established or incorporated by or under a Central Act Provisional Act or a State Act or an Institution recognized by the University Grants Commission as an equivalent qualification.  (2) Must have experience in translation work in Telugu atleast for a period of 5 years in a Government Institution or in a reputed newspaper office or any University.

Category (1)	Method of Appointment (2)	Qualification (3)
		(3) Must not have completed 40 Years of age on the first day of July of the year in which selection is made.
