The following notification shall be published in the Andhra Pradesh, Gazette.

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and all other powers hereunto enabling, the Government of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Translation Subordinate Service Rules, 1995, issued in G.O. Ms.No. 174, Law Department, dated 12-10-1995 as subsequently amended.

AMENDMENTS

In the said rules,

1. In Rule 3 (a) Against Categories 2 (a) and (b) in column (2) for the existing entries the following entries shall be substituted, namely :-
 - i) “ By Direct recruitment “.
 - ii) a) “ By Transfer of Junior Assistants / Typist of Translation Department or for special reasons by transfer from any other class or service “.
 - b) In the note for the figure “ 75% “ the figure “ 50% “ shall be substituted.

2. To rule – 7 the following proviso shall be added, namely, Provided that no person shall be eligible for appointment by transfer or promotion to the post of Junior Translator (Telugu) or (Urdu) unless he / she has put in not less than five years of service from which transfer or promotion is made.
