**ORDER:**

In the reference 1<sup>st</sup> read above, Government have sanctioned a scheme for construction of **Girijan Bhavans** during 2007-08. However, the scheme could not be implemented due to paucity of funds and also various other reasons.

2. Subsequently, various tribal organizations and tribal representatives have represented from districts to sanction **Scheduled Tribes Education & Cultural Hall (Girijan Bhavan)** in their District Headquarters which will be useful for ST youth and ST communities in connection with their various cultural, educational and developmental programs being implemented for STs in the State.

3. In the reference 2<sup>nd</sup> read above, the Engineer-in-Chief, Tribal Welfare, AP., Hyderabad submitted the line estimates along with architectural plan for construction of **Scheduled Tribes Education & Cultural Hall (Girijan Bhavan)** in each district / mandal headquarters with an estimated cost of **Rs.1.35 crores** with a plinth area of **6,185 Sq. feet** and requested for according administrative sanction for taking up the works.

4. As the proposed works are part of Tribal Sub Plan 2015-16, the proposals of constructing **(13) Scheduled Tribes Education & Cultural Halls (Girijan Bhavans)** with an estimated cost of **Rs.17.55 crores**, were placed before the Nodal Agency for TSP in its meeting held on **11.5.2015** as Agenda No.8.C, in which the Secretary to Government, Finance Department is a Member.

5. In the reference 3<sup>rd</sup> read above, the Nodal Agency for TSP has agreed to provide the same amount of **Rs.17.55 cores** for construction of **(13) Scheduled Tribes Education & Cultural Halls (Girijan Bhavans)** with an estimated cost of **Rs.17.55 crores** (@ one each per district) as per the proposals furnished by the Engineer in Chief, Tribal Welfare, vide its Resolution no.10/2015 and recommended for the approval of the State Council for Development of SCs/STs.

6. Thus adequate budget provision of **Rs.80.00 Crores** has already been made available under Budget Estimates for 2015-16 under the scheme of **Education Infrastructure**.

7. Accordingly, vide reference 4<sup>th</sup> read above, the Director of Tribal Welfare, A.P., Hyderabad has furnished proposals for sanction of construction of Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) at a cost of Rs.17.55 crores @ 1.35 crore each for 13 districts.

8. In the circumstances reported by the Director of Tribal Welfare, A.P., Hyderabad, Government have examined the matter in detail and hereby accord administrative sanction for construction of **Scheduled Tribes Education & Cultural Halls (Girijan Bhavans)** in the state @ one in each district, as indicated at **Annexure 1** appended to this order, at an estimated cost of **Rs.17.55 Crores**, duly following the guidelines prescribed below:

- I. The total estimated cost for construction of each Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) as approved by the Engineer-in-Chief (TW), Hyderabad is Rs.1.35 crores.
- II. Scheduled Tribes Education & Cultural Hall (Girijan Bhavans) shall be constructed within the approved unit cost and additional facilities such as beautification and additional accommodation shall be met by the District Collectors concerned from out of MPLAD funds/ACDP funds/EMF or other sources.
- III. Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) shall be constructed at the respective District Headquarter in the first instance in all districts excepting Chittoor, where it is proposed at Tirupathi.
- IV. The District Collector shall identify suitable Government site of one acre and allot it to the Department of Tribal Welfare for taking up construction of Scheduled Tribes Education & Cultural Hall (Girijan Bhavan).
- V. The administrative approval for construction of Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) shall be given only after site is allotted free of cost by the District Collector.
- VI. The construction work shall be taken up as per the type-design approved by the Engineer-in-Chief (TW), Hyderabad and shall be completed within a period of one year from the date of administrative sanction.
- VII. After completion of the construction, the Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) shall be handed over to the District Tribal Welfare Officer/ Project Officer of the respective district.
- VIII. The day to day management of Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) shall be entrusted to local ST Mandal Mahila Samakhya under the supervision of District Tribal Welfare Officer/Project Officer.
- IX. The Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) may be hired to ST people on rent basis for conducting marriage functions or any other social celebrations.
- X. Indicative tariff for hiring the Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) is appended to this order at **Annexure 2** which can be increased based on the demand and season with the approval of the District Collector.
- XI. The local ST Mandal Mahila Samakhya to whom the management of Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) are assigned shall maintain annual book of accounts and oversee the maintenance of the Scheduled Tribes Education & Cultural Hall (Girijan Bhavan).
- XII. The rent collected shall be utilized for the maintenance of the Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) such as electrical charges, white washing, electrical repairs or for any other works as per the requirement, duly obtaining the approval of District Collector.
- XIII. The indicative expenditure per month towards maintenance of Scheduled Tribes Education & Cultural Hall (Girijan Bhavan) shall be as follows:

9. The expenditure for construction of **Scheduled Tribes Education & Cultural Halls (Girijan Bhavans)** shall be debited to the following head of account

10. The Director, Tribal Welfare and Engineer-in-Chief shall take further necessary action and execute the construction of said works in a time bound manner during the current financial year through the Tribal Welfare Engineering Department.
