In the reference read above, the Prl. Secretary to Govt.(Resources & Expenditure), Finance Dept., AP, Hyderabad has stated that they have released the entire amount available i.e. Rs.4289.00 lakhs as 2nd instalment under 13th Finance Commission in anticipation of its receipts from Govt. of India and requested to issue administrative sanction for these grants.

The Director of Tribal Welfare, Andhra Pradesh, Hyderabad is requested to take necessary action accordingly and to incur the expenditure not exceeding the amount sanctioned above towards providing Drinking Water in Inaccessible Tribal Areas under 13th Finance Commission Grants and also requested to issue necessary instructions to the Executing Agencies/Field Officers for proper use of the sanctioned amount.

4. The sanctioned amount should be incurred as per the action plan approved by the High Level Committee and the Utilisation Certificates (UCs) should be furnished in the prescribed format to Finance (FC.IF) Department at the earliest.
