ORDER:-

In the reference 1st read above, Government have issued orders that accorded administrative sanction orders for the work “Providing additional infrastructural facilities to APTWRS junior college for Boys at Rajavommangi in East Godavari district” with an estimated cost of Rs.82.00 lakhs under NABARD-RIDF-XVIII grant.

2. In the reference 2nd read above, the ENC (TW) has stated that the work was entrusted to Sri L. Satyanarayana, Contractor, Chinnayyapalem on tender basis @ 3.33% less than ECV and the work was completed in all respects. She has further stated that the SE(TW), Visakhapatnam has stated that in one premises only, the APTW Residential Junior College for Girls is sanctioned and situated at Rajavommangi(V&M) in East Godavari district and no other institution for boys sanctioned and situated at Rajavommangi in East Godavari Dist. Further the SE(TW), Visakhapatnam has stated that final bill was submitted by the EE(TW), R.C. Varam to the APAO, W&P,Kakinada for arranging payments and the same was objected and it was requested to obtain ratification orders for changing nomenclature as”providing additional infrastructural facilities to APTWRS Junior College for Girls at Rajavommangi (V&M) in East Godavari District, Est. Cost. Rs. 82.00 lakhs instead of “Providing additional infrastructural facilities to APTWRS Junior College for Boys at Rajavommangi (V&M) in East Godavari district, East. Cost. Rs.82.00 lakhs.

3. The ENT(TW) has requested to issue amendment to the orders for changing the nomenclature of work as “Providing additional infrastructural facilities to APTWRS Junior College for Girls at Rajavommangi (V&M) in East Godavari districts Est. Cost. Rs. 82.00 lakhs instead of “Providing additional infrastructure facilities to APTWRS Junior College for Boys at Rajavommangi (V&M) in East Godavari district Est. Cost. Rs. 82.00 lakhs at in early date so as to close the work financially and physically.
