ORDER

According to the Special Rules framed for Andhra Pradesh Tribal Welfare service rules in the reference 3rd read above the post of District Tribal Welfare Officer and the post of Deputy Director under class-A in rule 3 of the said rules constitute 1st and 2nd level Gazetted posts. The Commissioner of Tribal Welfare, Hyderabad and Government are the appointing authorities for these posts respectively. Keeping the ad-hoc rule issued in the G.O. 2nd read above, the aforesaid special rules were amended making the Commissioner/Director of Tribal Welfare, A.P., Hyderabad as the appointing authority in respect of Deputy Director which is 2nd level Gazetted Posts then instead of Government.

2. Certain posts of Assistant Social Welfare Officers were transferred as Assistant Tribal Welfare Officers from Social Welfare Department to Tribal Welfare Department with effect from 5.5.2000 in G O. 5th read above in the exigencies of the Department. By virtue of this, the Assistant Tribal Welfare Officer will become 1st level Gazetted posts, the District Tribal Welfare Officer 2nd level Gazetted posts and the Deputy Director as 3rd level Gazetted posts in the Department. Government are the appointing authority for the 3rd level Gazetted posts. With effect from 5.5.2000 the Deputy Directors become 3rd level Gazetted posts and hence Government is the appointing authority for the post. The orders issued in the reference 4th read above have therefore become infructuous and are to be withdrawn or cancelled so that Government will become the appointing authority for the post of Deputy Director which is 3rd level Gazetted post and the Head of Department will be the appointing authority for 1st and 2nd level Gazetted posts in tune with the policy of the Government.

3. Government after careful examination have decided that the orders issued in the G.O. 4th read above be cancelled with immediate effect to fall in line with the policy of the Government and accordingly cancelled the said orders.
