**ORDER**

As per decision of Hon'ble Chief Minister on 9-7-1997 for separate Integrated Tribal Development Agency (ITDA) for Yanadis tribe for the districts of Nellore, Chittoor and Prakasham, Government have issued orders for preparation of perspective plan for the development of Yanadis living in the Nellore, Chittoor and Prakasham after taking up of base-line survey for sanction of ITDA for Yanadis vide G.O.first read above.

2. The Commissioner of Tribal Welfare has furnished proposals for creation of staff for the proposed ITDA Yanadis and budget vide his letter second read above. The Director of Tribal Welfare has also furnished the proposals for proposed ITDA Yanadis and base-line survey report on Yanadi Development Plan in the districts vide letter fourth read above.

3. The Government after careful examination of the proposals of Commissioner of Tribal Welfare, hereby issue the following orders for creation of ITDA Yanadis:

- i) ITDA Yanadis is hereby sanctioned for the districts of Nellore, Chittoor and Prakasham in the State.
- ii) The headquarters of ITDA Yanadis shall be located in Nellore District.
- iii) The ITDA Yanadis sanctioned in the districts of Nellore, Chittoor and Prakasham shall be registered as "ITDA Yanadis" under the Societies Registration Act. The Commissioner of Tribal Welfare, A.P., Hyderabad and the Collector of Nellore District shall take action accordingly and report immediate compliance. The ITDA will be implemented in the Yanadi Villages specified in the Yanadi Development Plan.
- iv) The financial resources of ITDA Yanadis shall consist of releases of the general sector under sub-plan for tribal areas, the funds at the disposal of Commissioner/Director of Tribal Welfare for special tribal welfare schemes and from Special Central Assistance allocated by the Govt.of India.

v) Sanction is hereby accorded to the posts in Annexure to this order subject to the condition that no post will be filled up except through redeployment of the existing staff.

vi) An amount of Rs. 40.00 lakhs (Rupees forty lakhs only) is sanctioned to begin with by saving within the allocation.

vii) The ITDA Yanadis shall have the Staffing Pattern as shown in the Annexure to this order.

viii) Sanction is also accorded for hiring of Jeeps for the use of ITDA Yanadis. Office furniture and equipment such as chairs, tables and cupboards/almarahs may be procured as per minimum requirement.

ix) The Project Officer, ITDA, Yanadis, shall have immediate administrative control over the Agriculture, Horticulture and Livestock Farms, Demonstration units, schools and Hostels etc. belongs to Yanadis in the three districts which are being financed by Tribal Welfare Department.
