**ORDER:-**

Section 77 (2) of A.P. Reorganisation Act, 2014 reads as follows:-

*77 (2) As soon as may be after the appointed day, the Central Government shall, by general or special order, determine the successor State to which every person referred to in sub-section (1) shall be finally allotted for service, after consideration of option received by seeking option from the employees, and the date with effect from which such allotment shall take effect or be deemed to have taken effect:*

*Provided further that as far as local, district, zonal and multi-zonal cadres are concerned, the employees shall continue to serve, on or after the appointed day, in that cadre:*

*Provided also that the employees of local, district, zonal and multi-zonal cadres which fall entirely in one of the successor States, shall be deemed to be allotted to that successor State:*

*Provided also that if a particular zone or multi-zone falls in both the successor States, then the employees of such zonal or multi-zonal cadre shall be finally allotted to one or the other successor States in terms of the provisions of this sub-section.*

2. In the ref second read above, the Government of India, by virtue of powers conferred under the third proviso to sub-section (2) of section 77 of the Andhra Pradesh Reorganization Act, 2014, has ordered that the employees of the Local, District, Zonal and Multi-Zonal cadres shall continue to serve on and after the 2nd day of June, 2014 in that cadre and also that the Employees of that categories which fall entirely in one of the successor State shall be deemed to be allotted to that successor State on and from that Day. Accordingly orders were issued in the ref 3<sup>rd</sup> cited, to the effect that all employees of the local, district, zonal and multi-zonal cadres that fall entirely in the State of Telangana shall stand allotted to the State of Telangana and likewise, all those falling within the successor State of Andhra Pradesh shall stand allotted to the State of Andhra Pradesh on and after the 2nd day of June 2014.

3. Consequent on demerger and transfer of 7 mandals of Khammam District to Andhra Pradesh State, the teachers and various categories of employees working in those areas at Zonal and District level have submitted representations to take them back to Telangana State as they are native of Telangana and working in those mandals which were the part of Khammam District before their merger into Andhra Pradesh State.

4. In the ref 4<sup>th</sup> read above, the Commissioner of School Education has informed that the teachers who are working in those 7 mandals deemed allocated in the successor state of Andhra Pradesh which are organised into district cadres the Khammam district would be the unit for employment and hence the employees who are working in these 7 mandals want to come back and serve in Telangana State. The Commissioner of School Education has therefore requested the Government to take a decision in respect of the employees of native of Telangana working in 7 sub-merged mandals/ villages of Khammam District.

5. In the ref 5<sup>th</sup> read above, the Collector & District Magistrate, Khammam has informed that out of total cadre strength of (3142) employees in all categories, (2173) employees working at present in (7) submerged Mandals. Out of which, (585) employees willing to work in Andhra Pradesh and remaining (1588) are willing to work in Telangana State and requested to take action in the matter.

6. Government after careful examination of the matter, hereby order:

- (a) If any employee belongs to any one of these 7 mandals, then he/she should be continued in Andhra Pradesh.
- (b) Based on options, from amongst the remaining employees, only those who belong to Telangana may be taken back and adjusted against vacancies. If there is any surplus, supernumerary posts would be created for them to be adjusted against future vacancies in the Zone or District.

7. The Prl Secys/ Secy to Govt of concerned Secretariat Departments and HoDs concerned and District Collector, Khammam are requested to take necessary action in the matter.
