ORDER:

Government of Andhra Pradesh has been implementing various developmental programs for the welfare of Scheduled Tribes in the state of Andhra Pradesh. A detailed review cum orientation work shop has been held by Hon'ble Chief Minister of Andhra Pradesh on 24.03.2016. The public representatives from scheduled castes and scheduled tribes along with the Departmental staff and field staff have participated in the said work shop. The work shop has discussed for implementation of various programs and has come up with various recommendations for improving the service delivery of the programs in an effective and timely manner.

2. The Director, Tribal Welfare vide her proposal read at reference 3rd, stated that, among the recommendations, one important recommendation is to permit Tribal Welfare Department to outsource certain facility management services in tribal Welfare Educational Institutions through service outsourcing. .

3. She further informed that, the objective of the recommendation is to:

- a) Ensure timely and effective maintenance of cleanliness, drainage & sewerage services including regular cleaning of septic tanks in Tribal Welfare Hostels, Ashram Schools, Govt. TW Primary Schools and Residential Schools.
- b) Ensure timely replenishing of consumables such as Washing powder, phenol, Cleaning equipment, bulbs etc.,
- c) Ensuring attending to petty repairs such as repairs to electrical wiring, water pipe lines, electrical motor repairs, small repairs to doors and windows, replacement of water taps in toilets and bathrooms etc.,
- d) Cleaning of rice and pulses.

4. She informed that, at present, these services are being obtained by the Hostel Welfare Officers locally and as per the powers delegated to him vide ref.1st cited above, read with reference 2nd cited above, he can incur expenditure upto Rs.20000/- per annum.

5. She further informed that, whereas, the budget for this purpose is provided under SH - 05, Educational Institutions, 272 - Maintenance and the Executive Engineers of Tribal Welfare are authorized to draw and disburse the amounts under this head. But, the Executive Engineer are not able to attend the works as they are too petty in nature and it is difficult for them to contract the works institution wise and get them executed and recorded on M-Book. Since, the Executive Engineers

are not able to utilize the grants and the Hostel Welfare Officers are also not able to draw the amounts under this head as per the procedure, the institutions are virtually left without proper day to day maintenance.

6. Keeping in view the circumstances, she has proposed to outsource the facility management and petty repairs activities of Tribal Welfare Educational Institutions on a service outsourcing basis.

7. Government after carefully examining the proposals furnished by the Director of Tribal Welfare hereby order that the facility management and petty repairs activities of Tribal Welfare Educational Institutions shall be outsourced on a service outsourcing basis.

8. The Director of Tribal Welfare, AP, the Secretary, APTWREI Society (Gurukulam) and Engineer-in-Chief, Tribal Welfare shall take necessary action accordingly.
